

The right of public prosecution is an important power granted by the law to the prosecuting authority to file a lawsuit against the criminal suspect on behalf of the State and to request the court to put on trial so as to implement the national penalty power. The function of public prosecution is the core and iconic function of the prosecuting authority. State Prosecutor is the procurator on behalf of the State to fulfill the right of public prosecution. He/she will appear in court on behalf of the State to support the prosecution. It is the most direct form of the prosecuting authority to exercise the right of criminal prosecution. In court, the public prosecutor shall not only fulfill the duties of accusing and proving a crime, but also shoulder the mission of protecting the legitimate rights and interests of the parties involved in the proceedings and supervising the judicial activities in the court; he/she shall debate fiercely with the defendant and its defenders, and his/her opinion and presentation must accept the defendant's questioning, rebuttal of the lawyers, the judgement of the court and the public scrutiny, his/her performance in the court is directly related to the effect of charging the criminal and also related to the image of the impartial enforcement of the prosecuting authority.
